- 3. That the Company has informed me that there may be dangers and hazards inherent to participants in its programs because of the activities involved, and that I personally recognize and appreciate that such dangers and hazards exist.

- 4. I accept and assume full responsibility for all harm and injury, of every nature, including death, which may occur to me or which I may suffer or cause to others through my participation in the programs and activities of the Company, and for all damages or loss to any personal property owned by me or damaged by me while I am participating in the programs and activities of the Company and during all travel to and from the same.
- 5. I will not sue, or otherwise make any claims against the Company, its owners, employees, instructors, or agents, for any personal injury, illness, death, property damage or loss I may sustain as a result of my participation in the programs and activities of the company, whether caused in whole or in part by the ordinary negligence or conduct of the company, its owners, employees, instructors, or agents.
- 6. In furtherance thereof, I agree to indemnify, hold harmless and release the Company, its instructors, employees, owners, and assigns, from and against any and all claims, demands, actions or causes of action, liability, costs or expenses, and all other damages on account of damage or loss to my personal property, my personal injury, illness, or death, or the bodily injury, death, or damage to personal property of others caused by me, which may result from my participation in the programs and activities of the Company which are not a direct result of any negligent act of the Company or its employees or agents.

- 9. This Release and Assumption of Risk shall be construed and interpreted pursuant to the laws of the State of Maine, and if any portion of it is held invalid, void, unenforceable or illegal, the remainder shall continue in full force and effect.
